1. The brief particulars of the Scheme of Arrangement are as mentioned below:

a) The Composite Scheme of Arrangement of the Company was approved by the National Company Law Tribunal, Hyderabad Bench vide its Order dated 03/11/2017.

b) Appointed Date: 31/03/2017

- c) Effective date: 23/11/2018
- d) Date of Allotment: 02/02/2018

f) Pursuant to Composite Scheme of Arrangement between Gayatri Projects Ltd (GPL), Gayatri Infra ventures Limited (GIVL) and Gayatri Highways Limited (GHL) {Formerly known as Gayatri Highways Private Limited - erstwhile Gayatri Domicile Private Limited} and their respective shareholders and creditors as sanctioned by the Hyderabad Bench of the Hon'ble National Company Law Tribunal; whereby the investment of GPL in Sai Maatarini Tollways Limited (SMTL), a Wholly Owned Subsidiary (WOS) of GPL is transferred to GHL and in consideration thereof, GHL has paid lum-sum amount of Rs. 180,16,03,000/- to GPL in the form of 1,24,60,000 equity Shares of Rs. 10/- each (post-split **6,23,00,000 equity shares of Rs. 2/-** as post approval of scheme by Hon'ble National Company Law Tribunal; there was split in the face value of Equity Shares of GHL from Rs.10 to Rs. 2 per share) and 16,77,00,300 redeemable preference shares of Rs. 10/- each Date.

Further, the scheme also comprises of Amalgamation of GIVL with GPL, post aforesaid transfer of investments, whereby GIVL has become WOS of GPL pursuant to share Purchase Agreement and therefore no new share of GPL has been allotted to the shareholders of GIVL.

Also, the Infrastructure Road BOT Assets Business of GPL has been transferred to and vested in GHL and in consideration thereof, GHL has issued its Equity Shares to the Shareholders of GPL in the ratio of 1 (one) Equity Shares of Rs. 10 each for every 1 (One) Equity Shares of Rs. 10 each held in GPL and in consideration thereof, GHL has issued 17,72,51,900 Equity Shares of Rs. 2 each (post-split in GHL as mentioned above) to the shareholders of GPL as on record date.

Prior to the Scheme, the pre-split paid-up equity capital of GHL was Rs. 2,00,000/- consisting of 20,000 equity shares of face value of Rs. 10/- each and post arrangement, the post-split paid-up equity capital is Rs. 479303800/- consisting of 23,96,51,900 Equity shares of Rs.2/-.

2. As per Exchange Notice No's. 20180119-1 dated January 19, 2018, Gayatri Projects Ltd. had fixed Record date as 31/01/2018 for giving effect to the Composite Scheme of Arrangement.
